

Rules and Regulations

This Agreement is between The Michigan Fun Fest (herein after "MFF") and _____ (hereinafter "Vendor").

1. Booths are reserved on a first come first served basis.
2. Vendor has to submit application with appropriate booth fees in order to be considered. Otherwise Vendor application will not be considered.
3. MFF is going to deposit any checks sent with application ASAP. So, Vendor must ensure that enough funds are available in their bank account.
4. There are neither explicit nor implicit guarantees that other vendors won't be selling similar or same products.
5. Even though we provide security at night, MFF is not responsible for any damages nor is it for the theft of any of your products or of your booth.
6. Vendor must make provisions for the safeguarding of their displays and are urged to insure themselves against property loss or damage and against liability for personal injury.
7. Vendor is required to operate their booth during the entire event.
8. Vendor shall, at its own expense and liability, transport all Goods to and from the Festival premises. Vendor shall provide a representative at its own expense to sell their Goods at the festival.
9. MFF Committee reserves the right to refuse any Vendor.
10. Vendor shall pay booth fees prior to the start of the festival.

11. MFF shall provide electricity for lighting purposes, as well operating small electric appliances such as fans, and small tv displays. No cooking allowed at Vendor booth, unless it is a Food booth.
12. Vendor is responsible for bringing his/her own cabling and electric fixtures.
13. If vendor withdraws, then no refund will be issued.
14. Priority is given to vendors that are going to stay the whole term of the festival. If a vendor wishes to rent a booth for a shorter period of time then Vendor has to wait till 1 week before the start of the festival to be notified if their application is accepted.
15. Vendor shall maintain a respectful attitude to customers, and the staff of MFF. If a Vendor misbehaves then they will be removed from the festival without any refunds.
